Course Description

This course examines community organizing and grassroots advocacy to empower ordinary people. We will consider how individuals who have all too often been marginalized in urban society come together to identify common problems, set an agenda, and then pursue change through collective action. How do such individuals mobilize resources, establish organizations, and seize opportunities to enhance their power and revitalize their communities?

The spatial context for our analysis of grassroots politics will be the city of Philadelphia. Like so many other American cities, Philadelphia suffered from the ravages of mass suburbanization, deindustrialization, deepening poverty and inequality, and mounting racial and ethnic tensions during the latter half of the twentieth century. We will begin the semester by reviewing the societal forces that contributed to urban decline, as well as the major political decisions at the local, state, and national levels that tended to exacerbate the impact of those forces. We will then take stock of current conditions in Philadelphia, which in some respects have improved in recent years, while highlighting the many social, economic, and political constraints that continue to limit the options of urban policy makers.

Next, we will move into the heart of the course by evaluating various models of community organizing and community development. From there, we will broaden our inquiry beyond community-based organizing to consider the potential of alliances between neighborhood groups and other entities advocating for change, including labor unions and faith-based organizations. Finally, we will study coalition-building strategies that encompass city-wide, regional, and national campaigns for popular empowerment.

A crucial component of this seminar is its blend of classroom-based learning with an experiential component featuring internships and participatory research. Along with weekly class meetings to discuss and analyze assigned readings on the theory and practice of community organizing, each student will be placed in an internship in Philadelphia with a community-based organization, public interest group, or city government entity concerned with popular mobilization around issues related to housing and community development, homelessness, economic development, education, and poverty. An underlying assumption of the seminar is that what students learn in the classroom will take on a deeper meaning if they are given the opportunity to confront directly serious problems affecting city residents and contribute to ongoing efforts to resolve those problems. The internship experiences will thus inform class discussions throughout the semester, as well as provide the foundation for a research project based on the organizing initiatives of city residents to address a major issue affecting one or more urban neighborhoods. We will conclude by reassessing the condition of Philadelphia and other American cities and the prospects for their revitalization through grassroots activism.
