### 1.0 Student's Desire to Participate in the Activity.

Student desires to participate in the activity described below:

It is expressly acknowledged that Student's participation in the Activity is voluntary and Student is in no way required to participate in the Internship.

### 2.0 Acknowledgment by Student of Risks and Dangers.

Student understands that there are risks and dangers involved in the Activity, including personal property loss or damage and physical injury and death. Student acknowledges that Haverford is not assuming any risk or liability on account of Student's participation in the Activity. Student understands and accepts those risks.

### 3.0 Release.

3.1 Knowing the potential dangers and risks of involved in the Activity, Student, on behalf of themselves and Student's family, heirs, and personal representative(s), hereby releases, and forever discharges, Haverford, its members, Board of Managers, officers, agents, employees, and any students participating in the Activity on behalf of Haverford, and each of their respective successors, heirs and assigns ("Releasees"), from any and all claims, causes of action or demands of any nature whatsoever which Student may have or which may hereafter accrue to Student, arising out of or related to any loss, damage, or injury, including but not limited to death, that may be sustained by Student or by any property belonging to Student, while participating in the Activity, whether caused by the negligence of Haverford, another Releasee or otherwise..

3.2 Student, on behalf of themselves and Student's family, heirs, and personal representative(s) covenants and agrees not to bring any cause of action against any Releasee based on any claim released hereby.

3.3 In signing this Release, Student acknowledges and represents that the student has read this Release, understands it and has had the opportunity to ask any questions and have this Release reviewed by an attorney of their choice. No oral representations, statements, or inducements, apart from the contents of this Release have been made by or on behalf of Haverford. Student executes this Release for full, adequate, and complete consideration fully intending to be bound by the same.

3.4 Student is at least eighteen (18) years of age and fully competent to sign this Release. If not, Student's guardian has signed below.

4.0 Governing Law; Forum.

The Undersigned further agree that this Release shall be construed in accordance with the laws of the Commonwealth of Pennsylvania. The term and provisions of this Release shall be severable, such that if a court of competent jurisdiction holds any term to be illegal, unenforceable, or in conflict with any law governing this Release the validity of the remaining portions shall not be affected thereby.
