

SUMMARY ANNUAL REPORT

For the Haverford College Voluntary TDA Plan

This is a summary of the annual report for the Haverford College Voluntary TDA Plan, EIN 23-6002304, Plan No. 004, for period January 1, 2018 through November 30, 2018. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$1,868,829. These expenses included \$2,915 in administrative expenses, and \$1,865,914 in benefits paid to participants and beneficiaries. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of November 30, 2018, compared to \$42,939,784 as of January 1, 2018. During the plan year the plan experienced a decrease in its net assets of \$42,939,784. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$2,336,763, including employee contributions of \$1,957,023, earnings from investments of \$204,510, and other income of \$175,230.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- an accountant's report
- financial information
- information on payments to service providers
- fiduciary information, including non-exempt transactions between the plan and parties-in-interest (that is, persons who have certain relationships with the plan)
- insurance information, including sales commissions paid by insurance carriers
- information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates

You also have the legally protected right to examine the annual report at the main office of the plan (Haverford College, 370 Lancaster Ave, Haverford, PA 19041-1392) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
