

SUMMARY ANNUAL REPORT

For the Haverford College Voluntary TDA Plan

This is a summary of the annual report for the Haverford College Voluntary TDA Plan, EIN 23-6002304, Plan No. 004, for period January 1, 2017 through December 31, 2017. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$1,101,394. These expenses included \$1,882 in administrative expenses, and \$1,099,512 in benefits paid to participants and beneficiaries. A total of 610 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$42,939,784 as of December 31, 2017, compared to \$35,175,598 as of January 1, 2017. During the plan year the plan experienced an increase in its net assets of \$7,764,186. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$8,865,580, including employee contributions of \$2,126,393, earnings from investments of \$5,495,248, and other income of \$1,243,939.

- insurance information, including sales commissions paid by insurance carriers;
- information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates;
